# TASK ALLOCATION

## ALL PARTNERS WILL:

- under the lead of PROSVETA, will create a survey meant to research Sts' awareness and attitudes related to children's rights, active citizenship and environment protection issues. **Prosveta will be responsible for the survey format and the questions linked to CE**, whereas **VIF will come up with the environmental protection questions**. **IPS will be responsible for creating the survey online and processing the results**. The survey will be carried out twice with the pupils - prior and after the trainings in order to evaluate the CEE TC efficiency.
- eTwinning projects will be launched. Topic: teaching citizenship and environmental skills to students. TA – Primary school teachers at EU level; TF - 12.2024. The eTwinning projects will be started by the teachers from the piloting and validation stages.

- ORGANIZE THE VALIDATION STAGE OF THE CEE TC RESOURCES AT NATIONAL LEVEL SO THAT ALL 40 TOPICS ARE PILOTED AT LEAST IN ONE CLASSROOM. EACH TEACHER WILL BE OBLIGED TO DELIVER 6 TRAINING SESSIONS DURING THE SCHOOL YEAR.
- ORGANIZE THE TEACHERS FROM THE VALIDATION STAGE TO PROVIDE FEEDBACK FOR EACH OF THE TOPICS THEY HAVE TAUGHT.
- COLLECT TEACHERS' FEEDBACK REGARDING THE CHANGES IN THE CLASSROOM RESULTING FROM THE TRAINING COURSE DELIVERY DURING SCHOOL YEAR 2025/26.

## WP4: SPECIFIC TASKS AND RESPONSIBILITIES

- INSTITUTO POLITECNICO DE SANTAREM WILL ORGANIZE A MOODLE COURSE WITH PARTICIPANTS FROM THE PILOTING AND VALIDATION STAGES, AND NEW TEACHERS. THE COURSE WILL FOLLOW THE STRUCTURE OF THE ON-SITE TEACHER TRAINING EVENTS IN TURKEY AND PORTIGAL BUT WILL ALSO PROVIDE FIRST HAND FEEDBACK FROM THE TEACHERS WHO HAVE ALREADY ORGANIZED TRAININGS FOR THEIR STUDENTS. THE MOODLE COURSE WILL COMPRISE SYNCHRONOUS ACTIVITIES (ONLINE SESSIONS, WHICH WILL BE RECORDED) AND ASYNCHRONOUS TASKS. ALL COURSE MATERIALS WILL BE AVAILABLE ONLINE FOR OTHER TEACHERS TO USE IN CASE THEY WISH TO LEARN HOW TO IMPLEMENT THE CEE TC.
- PROSVETA FOUNDATION WILL CONTRIBUTE TO THE STRUCTURE OF THE COURSE, TRAINING RESOURCES AND TRAINERS.
- APDNE AND VIF WILL PROVIDE TRAINERS AND COURSE PARTICIPANTS.

# WP5: OBJECTIVES

THIS WAY, ALL INTERESTED PARTIES COULD MAKE USE OF PROJECT RESULTS AND ORGANIZE TRAINING ACTIVITIES FOR PRIMARY SCHOOL STUDENTS IN CIVIC AND ENVIRONMENTAL EDUCATION.

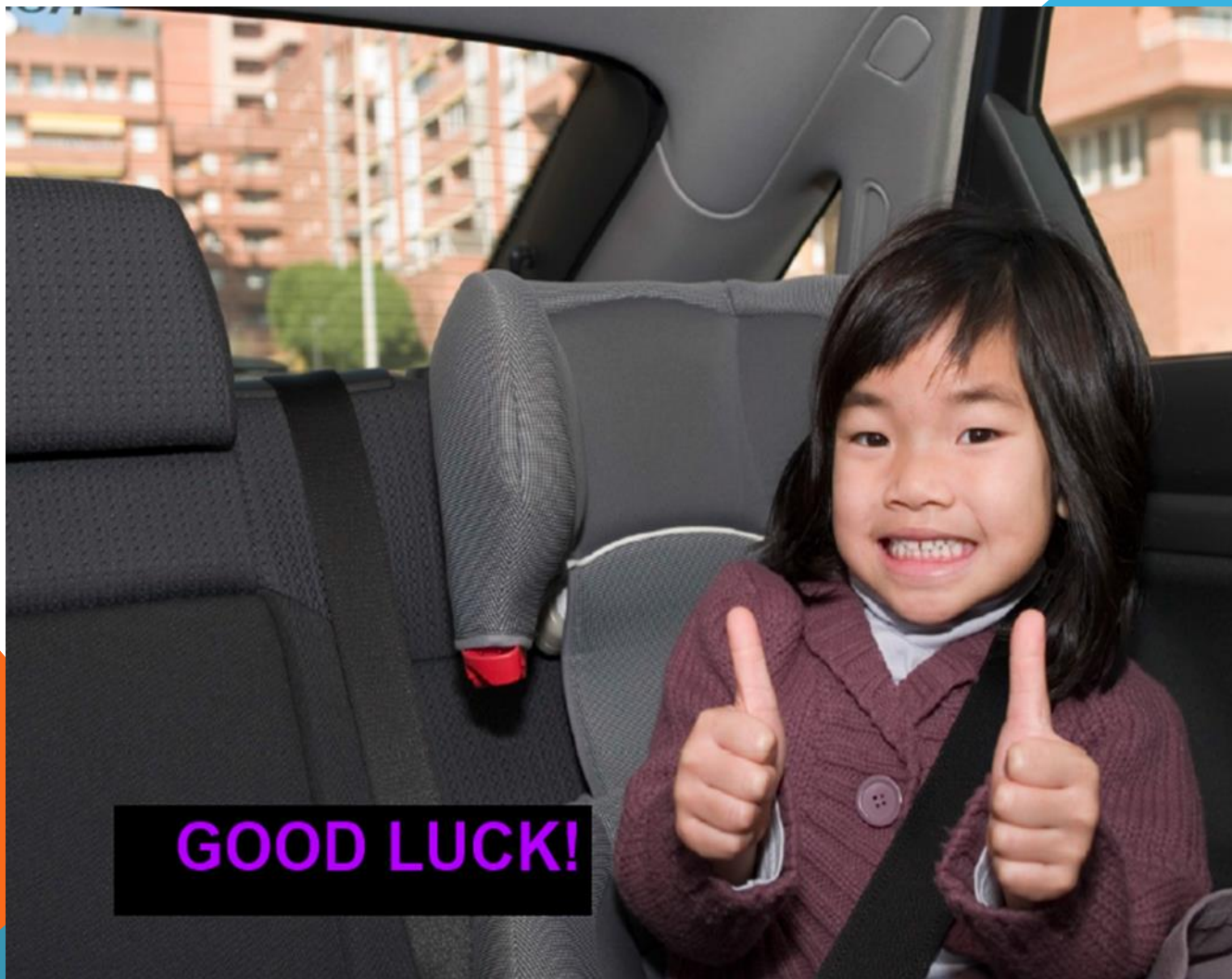
